November 7, 2025.

President - Lorrie Seigel called the meeting to order at 8:07PM

President Lorrie S. led the Pledge of Allegiance.

Chaplain - Molly Sides read a self-written Invocation.

President Lorrie S. thanked the following Past Presidents for their continued support, Diana Long, Kathy MaGouirk, Carla Hall, Terry Buchanan, Donna Matanane, Laura Teague, Amanda Armitage and Melissa Lewis.

Lorrie S. introduced MOA/NOMOTC workers, Claudia Contreras, Becky Hames Liediger, Conni Russell, Carla Hall and herself.

Lorrie S. asked the SCMOMC Inc. members to introduce themselves. State your name, your state position and your local club's name.

Lorrie S. reminded all Board of Directors to submit their reports to the President, the Vice President and your Officer In Charge. Please use email for your communication whenever possible and check your spam folder on a regular basis.

There are 42 Board of Director positions as of November 7th, 2025. We have 35 members in these 42 positions, 7 of those hold dual positions. By-laws state that a quorum for a Board of Director meeting is 1/3 of the members of the Board of Directors. $35 \div 1/3 = 12$ Board of Director members must be present to constitute a quorum. Quorum is met.

Everyone needs to make sure that their cell phones are in silent mode. Comments or photos about the Board meeting are not allowed to be shared on social media. Everyone has the right to voice their opinion. Only Board members may make motions and vote. To be recognized by the Chair raise your hand, once recognized, please stand and state your name club name and state position. Please wait to be recognized by the President before speaking.

Please remember that each topic has a 10-minute time limit for discussion. Each speaker gets 2 minutes to present her point. There are signs that will be shown indicating the 60 second mark, 30 second mark and when time has expired.

All motions must be submitted to the Recording Secretary in writing. Motion forms are available from the Recording Secretary and the Pages. All Board members have a right to make a report or pass if they choose.

To help with the flow of the meeting, please follow the agenda and be prepared. It is important to be courteous, listen and not to talk during any chairman's report.

President Lorrie S. made the following appointments, Minutes Approval committee: Kathy MaGouirk and Melissa Lewis. Timekeeper: Donna Matanane. Pages are from Temecula Valley MOMs: Ashley Matics and Agnes Orth. Lorrie S. asked if there are any objections to these appointments? Hearing none the appointments will stand as presented.

Lorrie S. gave the following reminders: under the members' site, the following forms are available: the Board of Director Listings, the State Calendar, the Confidential Club directory and the Officer In Charge listings.
